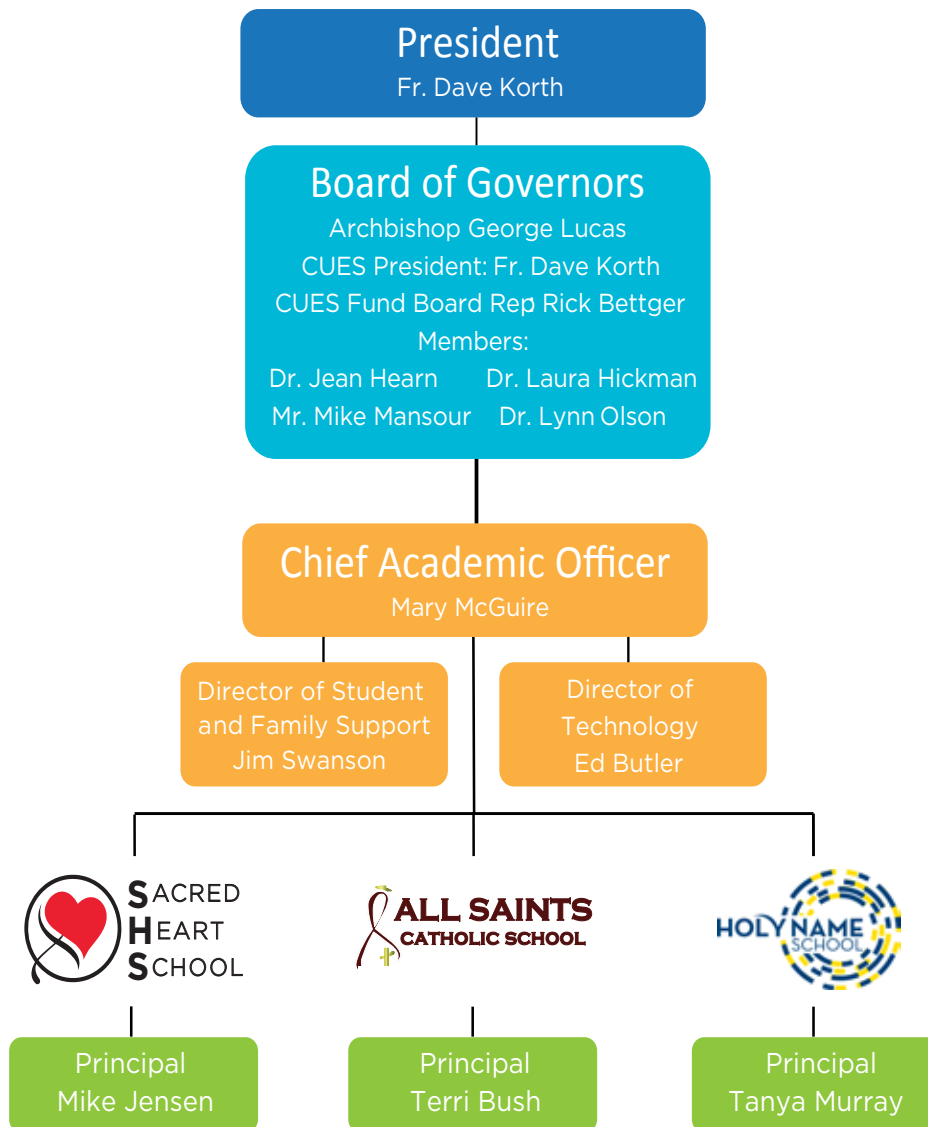

## STRONG GOVERNANCE MODEL

This model of governance allows us to gain insight and knowledge from our expert Board of Governors who are educators in Omaha and experts in their field. Our Board of Governors is committed to providing an upward success pattern for our students and families.

## ACADEMIC ASSESSMENT TOOLS

CUES School System uses a variety of academic assessment tools to obtain data that allows teachers to individualize instruction based on strengths and areas of need.

## NEW ACADEMIC INITIATIVE

**Blended Learning** is an approach to education that combines online educational materials and traditional classroom methods. It can be said that the blended learning method combines the best of both worlds in a manner that is less costly, time-saving and more personalized. Studies suggest that blended learning helps to close the education gap among low-income students in the areas of reading and math.

Blended Learning is being implemented across all three schools in Pre-K through 8th grade with a focus in Reading and Math.

## STRATEGIC COMMUNITY PARTNERSHIPS

Each of our three schools have intentional partnerships with various organizations throughout the community. These partnerships help to serve the whole family. Services provided by our partners include:

- Mentoring and tutoring services
- Beforecare, aftercare and summer programming
- Behavioral health services
- Extracurricular activities in performing arts and sports
- Adult programming: ESL Classes and Financial Literacy

## STUDENT AND FAMILY SUPPORT SERVICES

The Director of Student and Family Support is able to connect students and families with services beyond the classroom. This is done on an individual basis in order to provide families with the resources and tools they need to succeed.

## PARENTAL ENGAGEMENT AND ACCOUNTABILITY

Each school has implemented a PAC (Parent Ambassador Committee) where parents are strongly encouraged to play a bigger role in their child's education.

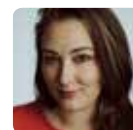

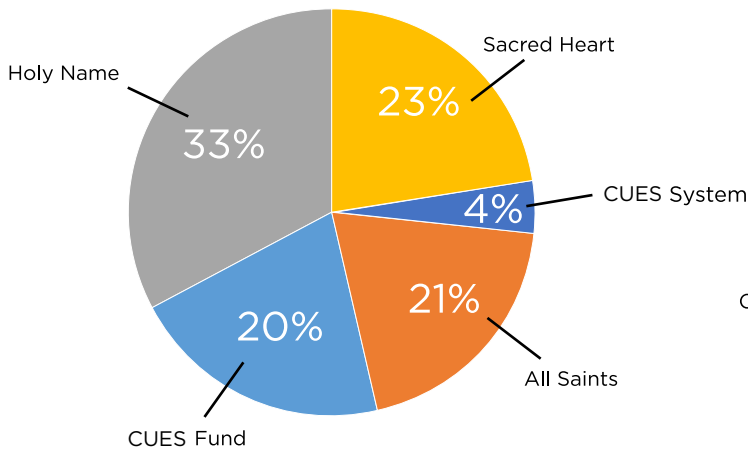

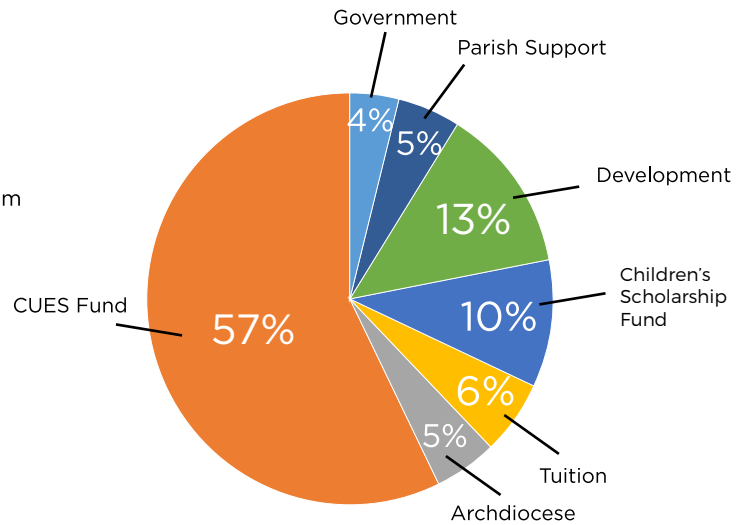


# CUES Revenues and Expenses

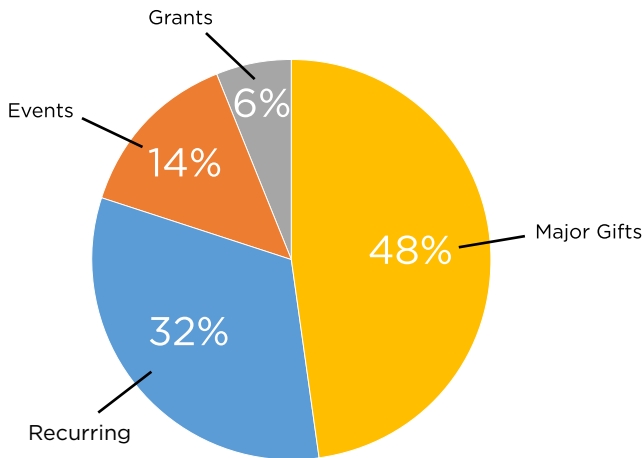
CUES Fund & System Expenses
